

### Morning Media Report, Sunday 28 July 2024:

Sunday Times (ROI) reports that the Central Bank of Ireland (CBI) spent EUR 350,000 on a four-day "retreat meeting" for 26 senior EU bankers and 22 officials. The cost included a five-star hotel, VIP packages at Dublin airport, golf buggies, a harpist, leather-covered notebooks and packets of mints. Accommodation and services for the 20-23 May meeting of the governing council of the European Central Bank (ECB) came to EUR 193,000 while EUR 117,500 was spent on official transport. The CBI said: "Each year the European Central Bank typically holds two governing council meetings outside of Frankfurt, hosted by a national central bank. This year Ireland [was the host]." "The meeting provided an important opportunity for the Central Bank to build on the strong collaboration with the ECB governing council and European partners," the CBI noted. Sunday Independent and The Sun (ROI) also report.

### Morning Media Report, Monday 29 July 2024:

The Sunday Independent reports the Central Bank spent more than €350,000 hosting a five-day "retreat" for a visiting delegation of senior bankers from the EU. The spend, which covered five-star accommodation, golf buggies, presentation mints, a hurling display and VIP airport costs, included a €193,000 bill for the exclusive Mount Juliet resort in Co Kilkenny. The Sunday Times (ROI) reports accommodation and services for the 20-23 May meeting of the governing council of the European Central Bank ECB came to €193,000 while €117,500 was spent on official transport. The Sun reports itemised spending released following a Freedom of Information request shows that €1,400 was spent on Parker branded pens. And the bankers had no reason for any bad breath as €276 was spent on boxes of promotional mint sweets.
